**Description:** StudioMA, Inc. worked with a team of architects for Hollywood Community Housing to create a facility that supported both the organizations offices and multi-family housing that included an onsite laundry mat, social services offices, a community pantry, and a community center. This project was especially rewarding for the team to be at the grand opening as a line of families and individuals registered to be selected to move into the apartments. The idea of having a courtyard and laundromat onsite was a goal of our clients from day one and allows busy working parents and caregivers to complete their responsibilities during the evening and yet stay nearby for young and older family members. Social workers are onsite, and the various community and training spaces are well used amenities.

In addition, StudioMA, Inc. has worked for many years for the neuropsychiatric department at UCLA. During this time, we have designed several facilities where we have incorporated trauma-informed design guidelines and the Department of Veterans Affairs design guide for Mental health – these parameters help the team prioritize and reinforce the importance of stake holders, the end users, and staff needs during each phase of the project. The attached images (Nathanson Family Resilience Center, UCLA Childrens Psychiatric Partial program at NPI, NPI Geriatrics Luskin Center presentation, UCLA A Disorders community and treatment spaces) show our participation and the support provided to our clients in their efforts to successfully inform the community, raise funds, design, and build.
